- Draft 1 of C37.21 was reviewed beginning at clause 7.1.5.8 where we left off at our Fall 2015 meeting
- There was discussion centered around open type control switchboards and if they
 are still an applicable construction type, the consensus was to leave them in the
 document and not to delete them
- Chapter 8, "General application guide" will need to be changed to an informative annex
- Change ambient air temperature range to be consistent with C37.20.1
- Chapter 9, "Handling, storage, and installation guide" will also need to be changed to an informative annex
- Add "c) Follow all applicable clauses found in NFPA 70 and NFPA 70E [B12]." From C37.20.1 to the installation requirements section
- Jeff Mizener will provide some suggested text for the surge withstand capability (EMC) portion of the document to make it consistent to C37.20.1
- A motion was made by Mike LaFond and seconded by Jeff Mizener to;
 - 1) Circulate a new draft of the document (Draft 2) with the changes that have been discussed by the working group
 - o 2) Make a PAR revision before May 20, 2016
 - o 3) Go to ballot
- The motion was voted on and approved by the working group
