Meeting Minutes

1. Call to order and introduction:

The Working Group for the revision of IEC 62271-111/IEEE C37.60-2012 ed. 2 held its 10th meeting on October 10, 2016 in Pittsburgh, PA USA in conjunction with the IEEE Switchgear meetings. Convener David Stone opened the meeting at 8:05 AM.

2. Roster Check:

Introductions were made. Attendance included 19 members of the Dual Logo Maintenance Team (DLMT) and 24 guests. Fourteen members of the DLMT were absent or excused. Refer to the attendance list at the end of this report.

3. Agenda and Previous Meeting Minutes

The agenda was reviewed and approved without change. The meeting minutes of the C37.60 Hilton Head, SC meeting held in April 2016 were approved as previously distributed.

4. Meeting Highlights

- **Documents available on IEEE website**: All documents from the DLMT will be posted on the IEEE web site. Members may contact the Convener for the log-in ID and password.
- Actions since last meeting were summarized:
 - The 3rd IEEE ballot closed on September 18, 2016.
 - Seventy-nine comments were received; about 2/3 were given a preliminary disposition prior the meeting, the rest were discussed.
 - The updated list of comments with dispositions will be sent to the DLMT members for review, approval and/or comment. **Note: list sent out on Oct 11**.
 - In order to achieve an earlier review of the IEEE comment by IEC NC's prior to the FDIS ballot, a selection of the IEEE comments that are considered of significance will be submitted to the IEC by way of the USNC response to the CDV.
- The IEC CDV ballot was delayed by 3 months to allow for translation into French. The CDV was distributed on September and is not due until December 9.
- Final dispositions on all comments from both IEEE and IEC will be reviewed once the IEC CDV results are available.

5. Next meeting:

It is expected that the next meeting will be held in Europe. The major topic will be the comments from the IEC CDV. Date and location of this meeting is to be determined, most likely in January 2017. Members are asked to consider their attendance at this meeting.
