4. Working Group Status Reports

C37.20.2 Ad Hoc – Inspection Windows
 P. Barnhart: No meeting minutes provided.

Ad Hoc members: Paul Barnhart, Jim Bowen, Carl Schneider, Don Elliot, Sergio Flores, Mike Wactor, Marcelo Valdez, and Tim Rohrer.

P. Barnhart: Ad-hoc will need more time to report back to SA S/C. Ad Hoc will target to convene within 2 months to complete effort.

Actions for SA S/C Chair: No further action required.

b. C37.20.2 Ad Hoc – Logic Level/Communication Wire

P. Barnhart: No meeting minutes provided.

Ad Hoc members: P. Barnhart, T. Burse, J. Jarque, S. Cohn, R. Boyce, E. Byron, T. Hawkins

P. Barnhart: presented a summary of ad-hoc findings and recommendations on control wire, wiring across a hinge, wire type, and wire size. Presentation document will be submitted to SA S/C Minutes website.

SA S/C general discussion and desire to include a common requirement for this subject across C37.20.1, C37.20.2, C37.20.3, and C37.21 documents. C37.21 requirements are the closest to the ad hoc recommendations but not identical. C37.20.1 does include a requirement to require the door to open a full 90 degrees.

SA S/C question: Does the ad hoc recommend a requirement for repeated door movement?

P. Barnhart: No consensus to determine how many wires or which size to perform such a test.

SA S/C question: Would these recommendations apply to the bonding strap across the door hinge?

P. Barnhart: No. The bonding strap is not a control wire.

SA S/C general discussion on how to incorporate the proposed requirements and other future ad hoc recommendations into the same documents. How many amendments are allowed per document?

E. Spiewak: Standard documents are limited to three amendments and some of these documents are less than a year old. Recommend that the SA S/C accumulate the proposed changes and then begin amendment activity.

T. Burse: A WG requires a PAR. A study group must complete activity within six months. An ad hoc has an unlimited amount of time to complete its scope of effort.

Motion by P. Barnhart to continue work in the ad-hoc for the purpose of proposing common requirements (expected to be included in amendments at a later date) for C37.20.1, C37.20.2, C37.20.3, and C37.21 such that the "Wire Type", "Wire Size", and "Wiring Across the Hinge" sections have requirements that are consistent across all the standards, with the understanding that C37.20.1 will retain any special requirements for DC control wiring that may not exist in the other standards.

Furthermore, to provide these requirements to the working group for C37.20.9, such that these requirements will also be harmonized. 2nd:D. Edwards.

Motion approved by the SA S/C.

c. C37.20.2 Ad Hoc – Voltage Dividers

Ad hoc members: D. Elliot

D. Elliot: presented a summary of ad-hoc findings and recommendations on voltage dividers and potential IEC documents available to reference on this subject. Presentation document will be submitted to SA S/C Minutes website.

E Byron: "Voltage Detection and Indicating Systems", IEC 61243-5, and "Voltage Presence Indicating Systems", IEC 62271-206, are being combined into a new standard 62271-213 "Voltage Detection and Indicating Systems". IEC 62271-214 is the new standard being developed called "Internal Arc Classification for Pole Mounted Equipment".

SA S/C general comment that TC 37 is the sponsor of these documents. There is no publishing timeline.

A. Morse and E. Byron volunteer as members of the ad hoc.

N. McQuin: A possibility of high voltage going into the control circuit does exist.

P. Barnhart: UL has specific requirements to address this concern.

D. Elliot: Ad hoc will continue work on this subject and collect a recommendation back to the SA S/C for inclusion in a future amendment effort.

Actions for SA S/C Chair: Investigate capturing such recommendations into the SA S/C Document Status file to retain recommendations from ad hoc groups.

d. C37.20.7 – Guide for Testing Medium-Voltage Metal-Enclosed Switchgear for Internal Arcing Faults
