Comment resolution during the meeting disposed of all 11 Comments.

- The majority of comments received were suggestions for improvements to the document which
 would involve adding new requirements which were not part of the document previously. These
 comments were out of the scope of the recirculation. The WG determined that the absence of the
 proposed new information was not a serious defect in the document and rejected the proposed
 additions.
- Two comments were with respect to a typographical error which crept in during the addition of other text on the line; some previously present text did not properly wrap to the next line but was deleted. Restoring the inadvertently deleted text was agreed upon by the WG to be an editorial change. It was left to the chair to work with IEEE –SA to determine if a recirculation ballot was needed to close the document of if the correction could be made and the document sent to RevCom. If a recirculation was needed, the chair was authorized the recirculate and dispose of any comments by working with the previously identified ballot resolution group if needed.
