2. 1900.7 reference model discussion

Following questions regarding 1900.7 reference model

Q: Is the 1900.7 sensing SAP equivalent to the 1900.6 SAP?

A: In principle yes. The most appropriate interfaces would be the C-SAP, but also the M-SAP could be considered. There is no guarantee that the 1900.6 SAPs provide all information and control functionality required by a 1900.7 compliant system. This has to be further evaluated.

Q: Can 1900.6 SAPs be utilized to obtain device geolocation information?

A: In principle yes, but this capability has been included newly in 1900.6a. Therefore, it is not a mandatory feature. In any way, a query would return the location of the sensor and not that of an associated communication device.

Q: Can 1900.6 SAPs utilized to communicate with geolocation databases?

A: Most likely not. A 1900.6 distributed sensing system does not provide database functionality nor does it provide capacity to pass-through communication between a database and a communication device. Some of the 1900.6 SAP primitives may be used to obtain regulatory information. But this is not sufficient and was never intended to implement enablement procedures or similar functionality.
