Why should you become a member?




- Technical information exchange with some of the top engineers from the industry


Kinds	Content
Qualify Condition	Must IEEE & IEEE-SA Member
Voting Right	Voting right can be obtained when the member participates the same TG meeting for 3 consecutive times Member participation is fully recognized when the attendance rate of the TG meeting is above 70% (IMAT Rule) However, the member who participated #1, #2 and #3 meetings may receive the voting right even though the attendance is not satisfied.
Member Type Ratio	Industry 60% / Academia 40%
