#### **Fundamentals**

- IEEE develops high-quality standards intended for broad adoption
- In general, the best standards are those that balance the needs and interests of all stakeholders
- IEEE standards development is open to all interested parties
  - Openness means not being restricted to a particular type or category of participants
- IEEE standards development processes shall not be dominated by any single interest category, individual, or organization

### **Dominance**

- Potential dominance in the IEEE standards development process, including Sponsor ballots, as evidenced by an unduly high proportion of individuals employed by or affiliated with a single entity or from a particular balloting classification is unacceptable, counter to open and fair participation by all interested parties, and deprecated by the IEEE-SA Standards Board.
  - IEEE-SA Standards Board Bylaws (Dec. 2016) § 5.2.2.3

### What Is Affiliation?

- Basic definition: "An individual is deemed "affiliated" with any individual or entity that has been, or will be, financially or materially supporting that individual's participation in a particular IEEE standards activity."
- Employers and Others: "This includes, but is not limited to, his or her employer and any individual or entity that has or will have, either directly or indirectly, requested, paid for, or otherwise sponsored his or her participation."
  - IEEE-SA Standards Board Bylaws (Dec. 2009) § 5.2.1.5



### Disclosure of Affiliation Is Mandatory

- "Every member and participant in a working group, Sponsor ballot, or other standards development activity shall disclose his or her affiliation, which includes employer(s) and any other affiliation(s)."
  - IEEE-SA Standards Board Bylaws (Dec.2016) § 5.2.1.5
- "An individual's status as representing an organization shall be based on self-disclosure of affiliation in compliance with the IEEE-SA policy on Disclosure of Affiliation and on other information that may be available to the IEEE-SA Standards Board and the Sponsor."
  - IEEE-SA Standards Board Bylaws (Dec. 20169) § 5.2.1.3.1

# Difference between Employer and Affiliation

- An affiliation includes, but is not limited to, an individual's employer and any individual or entity that has or will have, either directly or indirectly, requested, paid for, or otherwise sponsored his or her participation.
- An employer is typically the entity that would be reporting an individual as an employee for tax purposes.
- If you are consulting or contracted with another entity, your employer and affiliation will typically be different [e.g., your employer, self-employed, or your consulting firm name as the employer; the client(s) as the affiliation].
- Do not assume that the IEEE-SA will conclude your affiliation is the same as your employer. You must declare any affiliation even if it is the same as your employer.



### **False Declaration or Refusal**

- If it is determined that a person has made a false or misleading declaration of affiliation, their participation privileges may be suspended or revoked. This may be limited to the particular project or may, if warranted, cover all IEEE-SA activities. Similarly, if warranted, penalties may extend to the participant's employer and/or any person or entity that is considered an affiliate.
- If you refuse to disclose your affiliation, as outlined in IEEE-SA governance documents, you will lose certain rights. In a working group where voting rights are gained through attendance, no attendance credit will be granted if affiliation is not declared. Similarly, voting rights will be removed if affiliation isn't declared.

### False Declaration (cont'd.)

- A person who believes that a participant's disclosure is materially incomplete or incorrect should report that fact to the appropriate Sponsor(s).
  - Sponsors not required to "police"

## How Does a Consultant determine Affiliation?

### ■ For Consultants: The general answer is in the definition.

- An individual is deemed "affiliated" with any individual or entity that has been, or will be, financially or materially supporting that individual's participation in a particular IEEE standards activity. This includes, but is not limited to, his or her employer and any individual or entity that has or will have, either directly or indirectly, requested, paid for, or otherwise sponsored his or her participation.
  - An affiliate(s) is (are) the person(s) or entity(ies) that has been or will be financially or materially support your participation

## What if I Consult for Multiple Affiliations?

- If you represent more than one affiliate or multiple companies that are financially or materially supporting your participation, you should declare all of them. A small number of entities are more likely to be influencing your positions. With a large number of entities, with none explicitly or implicitly influencing your positions through financial or other incentives, it is less likely that your positions would be influenced by the relationship. The person disclosing has to honestly judge if their positions are "materially supported" and if so, declare it.
- If you consult for multiple companies but none pay for your time or expenses to attend standards development meetings, you are affiliated with those companies if they are influencing what positions you take on issues (e.g., if continued work is probably dependent on taking an agreeable position, then you are being influenced by that affiliate).

### Why Do We Have to Do This?

- From IEEE's perspective: Compliance is important for preserving openness and preventing dominance
  - Tools for monitoring group activity and composition
  - Additional remedies
- From your perspective: more transparency in who you are dealing with and what their agenda might include
- The requirement applies to both individual and entitybased standards development projects.
- It is consistent with the IEEE Code of Ethics requirement to disclose conflicts of interest.



## When Will I Be Asked to Declare Affiliation?

- When registering an interest in myProject
  - via Manage Activity Profile
- When joining a sponsor ballot group
- When registering for a working group meeting
- At an in-person working group meeting
- At an electronic or teleconference working group meeting
- At pre-PAR study group meetings
- Whenever an individual is aware that the ownership of his or her affiliation(s) may be material to the process, or when the Sponsor or the IEEE-SA Standards Board requests, that individual shall also declare the "ultimate parent entity" of their affiliation(s).
  - IEEE-SA Standards Board Bylaws (Dec. 2016) § 5.1.2.3

Note: "Working Group" includes Working Groups, Task Groups, and other standards-developing committees with a PAR approved by the IEEE-SA Standards Board.



## Ways to Declare Your Affiliation

- IEEE myProject via your Account settings
- Sign-in sheets during meetings
- Electronic sign-in during registration processes
- Verbally when speaking during discussions, joining teleconferences and web conference meetings
- During balloting, document sharing and other electronic communications
  - Note: affiliations must always be kept up to date



## **Sign-in Sheet Minimum Requirements**

- Full Name
  - For the purposes of identification
- Employer
  - Your employer is always to be considered an affiliation
- Any Other Affiliations
  - Other than your employer, list all other organizations you would consider to be materially supporting your participation in IEEE standards development activities

## Confidentiality, Non-Disclosure, and Consequences

- Failure to disclose affiliation(s) can result in complete or partial loss of rights to participate in IEEE-SA activities
- Confidentiality agreements
  - "An individual is not excused from compliance with this policy by reason of any claim of a conflicting obligation (whether contractual or otherwise) that prohibits disclosure of affiliation(s)."
  - Any other result would permit participants and those seeking to influence a group a "free pass" around IEEE rules

### **Use of Information**

- How will this information be used?
  - All standards development group employer and affiliation declarations will be considered if there is an appearance of dominance in the standards development project or governance body.
- Will this information be shared with anyone else other than IFFF-SA?
  - Yes, employer and affiliation of participants is to be included in the minutes of a standards development meeting. Because minutes are to be available to all participants, the declarations are considered public information.

#### A Note On GDPR

Beginning 25 May 2018, all IEEE meeting sign-in sheets, invitations for teleconference and web conference meetings shall also include the following GDPR language in order to be in compliance with IEEE's GDPR policies:

"By choosing to attend this meeting, you acknowledge and agree that your personal data will be documented for IEEE standards development purposes to comply with policies and procedures, legal and accreditation requirements, and evaluation of patent claims by patent offices. IEEE must capture your personal data for these purposes, and will provide information about activities related to standards development groups in which you participate. IEEE standards development participation is documented through various methods, e.g., rosters, submission documents, email reflectors, records of meeting attendance, responses to ballots, publicly available participation lists, and declaration of affiliations. See the IEEE Privacy Policy at <a href="https://www.ieee.org">www.ieee.org</a>."
