

# IEEE 802 March 2019 Rules Motions

## 10.0 Revision of Sponsor P&P

- Revisions to these P&P shall be submitted to the Sponsor no less than 30 days in advance of a motion (or conclusion of an electronic ballot) to approve them. Amendments in response to comments on the P&P are permitted. Insufficient time to consider complex amendments is a valid reason to vote disapprove. A motion to revise the Sponsor P&P shall require a vote of approve by at least two thirds of all voting members of the Sponsor.
- We have 6 officers, 9 voting WG/TAG chairs
  - 15 voting members, 2/3 approval is 10 affirmative votes

## 15. Revision of the IEEE 802 LMSC OM

- Revisions to the IEEE 802 LMSC OM shall be submitted by a Sponsor member to the Sponsor no less than 30 day in advance of a Sponsor Vote to approve them. The Sponsor member proposing the revision may modify the proposed revision during the 30 days prior to a Sponsor Vote (in response to comments). Insufficient time to consider complex modifications is a valid reason to vote disapprove. A motion to revise these documents shall require a vote of approve by at least two thirds of all voting members of the Sponsor. Votes to approve revisions shall be taken at a plenary session. If approved, revisions become effective at the end of the plenary session where the votes were taken.
- We have 6 officers, 9 voting WG/TAG chairs
  - 15 voting members, 2/3 approval is 10 affirmative votes

# Standards Committee Vice Chairs

- 3.0 Officers
  - There shall be a Standards Committee Chair, a First Vice-Chair~~(s)~~, a Second Vice-Chair, a Treasurer, a Recording Secretary and an Executive Secretary.
- 3.1 Election or Appointment of Officers
  - *Vice Chair*~~(s)~~
  - The Standards Committee Chair appoints a ~~(1st)~~First Vice Chair and ~~may appoint~~ a ~~2nd~~Second Vice Chair. The First Vice Chair and Second Vice Chair ~~Vice-Chairs~~ are confirmed by the Standards Committee.
- Remove parentheses around “s”: 3.4.2 (2 locations), 4.7 (1 location), 4.8 (1 location)

# PAR Study Groups

- New baseline only has “PAR Study Groups”
  - ECSG becomes “PAR Study Group formed as a subgroup of the Standards Committee”
  - WGSG becomes “PAR Study Group formed as a subgroup of a Working Group”
- WG P&P remains the same, Study Group operation is defined in IEEE 802 LMSC P&P as before
- Will describe rationale to AudCom as part of submittal
- Also, Chairs of Standards Committee PAR Study Groups from list of non-voting members, this is covered under Chairs of Subgroups

  - Section 1:
    - Replace “It is referred to throughout this document as IEEE 802 LMSC. The IEEE 802 LMSC Executive Committee (EC) acts on behalf of IEEE 802 LMSC as a Standards Committee as defined and required by IEEE Standards Association (SA) governance. The IEEE 802 LMSC EC is referred to throughout this document as the Sponsor.” with “It is referred to throughout this document as the Standards Committee.” and a footnote that says “In previous documents, the Standards Committee was also referred to as the IEEE 802 LMSC Executive Committee or EC.”
  - Section 2:
    - Delete acronym for EC
    - Change ECSG to be PSG (PAR Study Group)

## Update Standards Committee name (2)

- Change EC to be IEEE 802 LMSC in Figures 1 and 2.
- Change EC Study Group to be PAR Study Group in Figure 2.
- Title of 4.1 becomes IEEE 802 LMSC
- 4.1.2 EC → Standards Committee (3 locations)
- 4.3.1 ECSG → PAR Study Group ( 2 locations)
- 5, 5.1.1. ECSG → PAR Study Group (1 location each)
- 5.1.1, 5.1.2 EC → Standards Committee (4 locations)

## Standards Committee name (3)

- 9.2 EC → Standards Committee (1 location)
- 15.1 Change EC to be Executive Committee
  - Also change locations where it appears for the Working Group Executive Committee.
