Nendica ICAID Background

- Nendica
 - IEEE 802 "Network Enhancements for the Next Decade" <u>Industry</u>
 <u>Connections Activity</u>
- Industry Connections Activity
 - Program within IEEE SA
 - Operated by Industry Connections Committee (ICCom)
 - Overseen by CAG
 - no longer under IEEE SASB
 - · no longer under IESS SMDC
- Industry Connections Activities operate under authorization specified in an Industry Connections Activity Initiation Document (ICAID)
- Nendica Authorization
 - March 2017 March 2019 (ICAID IC17-001-01)
 - March 2019 March 2021 (ICAID IC17-001-02) extended to Sept 2021
 - September 2021 September 2023 (<u>ICAID IC17-001-03</u>)

Nendica ICAID Extension - 2023

- 2023-03-16: 802.1 WG motion
 - 802.1 authorizes Nendica to prepare, during its scheduled meetings, a draft ICAID renewal for presubmission to the July IEEE 802 Plenary
- 2023-05-25: Nendica motions
 - approved "<u>Draft Nendica ICAID renewal to September 2025</u>" (Rev. 6) and
 "Draft Nendica ICCOM report" (Rev. 2).
 - Forwarded to IEEE 802 LMSC
- 2023-07-13: Nendica finalized <u>ICCom report</u> (Rev. 3)
- IEEE 802 LMSC motion, 2023-07-14
 - Renewal agreed by IEEE 802 LMSC
 - *Forwarded to ICCom, 2023-07-19*
- ICCom action, 2023-09-12
 - Recommended renewal
 - Also recommended that the ICAID be subject to two-year auto-renewal
 - auto renewal each two years until termination request
 - Recommendation goes to CAG for 10-day ballot

 - Your Industry Connections Activity Initiation
 Document (ICAID), IC17-001 IEEE 802 Network
 Enhancements for the Next Decade was recommended by ICCom for renewal and approved by the CAG on 21
 September 2023. A copy of it is attached for your records in word and pdf formats.
 - ¹ Your ICAID was approved for renewal until September 2025 and will auto-renew thereafter with no further actions from NENDICA (unless there are revisions to the approved ICAID or you wish to sunset the activity). We'll miss seeing your renewal. ⁽²⁾
