- a) Shoji-san presented the case for the two path model. There were discussions on the simplicity of the model, need to reduce the number of models, if the two ray model (as it relates to the desk top allocation) is too specific and the possibility of merging/capturing the two-path model into SV. No decision was reached. The action item is for Shoji-san and Su-Khiong to exchange emails (through the Reflector) until some reasonable agreement is achieved.
