Suggestion #1 : Shorten timeline

Minimize number of recirculations

- Seek to finalize in 2 recirculations

Get MEC (Mandatory Editorial Committee) in SA involved in D2 versions

Considerations

- IEEE process

Suggestion #2 : Parallel Processing

Parallel processing of technical comments

Break group into “ad hoc” subgroups to come up with recommendations

- MAC/PHY
- Section/Sub-section based

Recommendations will then be discussed in the TG7 for finalization

Suggestion #3 : Comment strategy

Resolve “trivial” technical comments that do not require contributions/discussion first .

Consider group voting.

Assign people for developing contributions for resolving non-trivial comments.

Contributions must be made before Wednesday for discussion in this meeting

Tentative resolutions need to be obtained at this meeting

Suggestion #4 : Additional time allocation

Schedule additional “ad hoc” sessions in this meeting in the mornings for comment resolution

- Night sessions can also be considered, depending on committee interest

Getting attendance credit for “ad hoc” sessions

Technical editor can run these sessions

Suggestion #5: Schedule “Ad hoc” meeting in July

Additional meeting for comment resolution
