

UWB Applications expected where 802.11 systems may be present:

Key Fob/smart access

Follow me

Secure POS

Safety monitoring systems

Action: group to consider application and usage scenarios, and provide input on likelihood and the severity of potential impact of co-located 802.11 devices operating according to the proposed rules in the NPRM.

Impact levels:

(1) Severe: most likely prevents proper operation of 802.15.4 UWB and/or 802.11 systems, or degrades performance to a degree that it is unusable as perceived by system users.

(2) Moderate: Degrades performance of one or both systems to a degree that would be noticeable but may be tolerated.

(3) No big deal: Users would not be aware of any impact




Figure 1: Safe Travels Everyone
