Thursday, 14 Jan, 2021, PM3

Chair called the meeting to order at 3:03 PM PST.

Reviewed the opening report/ Agenda, doc# 27rev0

Went through meeting, patent, and other IEEE guidelines. And called for potential essential patents, *nothing heard*.

Kunal goes through the 15.4 2020 Cor1 PAR document that was approved by the WG during the July Plenary and also the PAR document approved by NesCom.

Chair goes through the document# 171-00 and present the technical error and proposed resolution as the overview.

Henk goes through the proposal doc#29rev00

There is a comment on the proposal, is the rate mode included in the proposal also covers the lower MCS for OFDM options.

The proposer responded with yes, it is considered part of the proposal.

There is a comment that if the lower mode is planned to be supported with better sensitivity it would not have chance to utilize the mode.

There is a comment that for simplicity and clarification, the changes needs to be made which are in align with the scope.

Chair suggest that if the technical error requires to be fixed which is not functional per currently specified in the standard, which needs to be address in the corrigendum group. Anything related to the enhancement feature should be considered as the amendment to the standard.

There is a comment that the removing technical details or enhancement from the standard is not part of the corrigendum and needs to be addressed at a later stage in the amendment.

There is a comment that the other proposal also requires more updates on the frame format, so need discuss further if it fits within the scope.

Ruben presents doc#393rev1

There is a comment that the proposed text is mainly editorial of changing from MCS to data rates

There is a comment that the definition for the rate mode is already described in 15.4g standard but looks like was modified in the 2015 version of the standard.

The proposer agreed to consider the original language to clarify the definition.
