- Chair Faure asked if the members of PLC-SC see a need for further actions:
 - Steven Palm asked if there is a way to prevent further actions taken by ITU to modify IEEE 1905.1 and how the activities in ITU G.hn project can be monitored.
 - o Purva reported that he is not aware of a new project in ITU dealing with that
 - Steven Palm suggested to address the concerns and it was discussed that P1905.1 should set up a liaison.
 - Steven Palm elaborated that the approach of ITU was not taking interoperability into account (and would promote this fact). The proposal was approved for the study group meeting in Geneva and was part of the agenda, so ITU was endorsing the violation of copyright and breaking interoperability.
 - o General question was if there is a way of preventing another SDO to change the standard and cause non interoperability.
 - o Bill reported that there is a meeting planned between ITU and IEEE to discuss week of 13th July, Agenda is unknown. Check with Noelle about further details.

Purva Rajkatio moved to instruct the PLCSC Chair to contact Konstantinos to assess the following point:

- o The ITU and its members shall be made aware of the IEEE copyright policy
- The ITU and its members shall be made aware that that IEEE shall be contacted before any project / contributions based on IEEE standards are made.
