# 2. Approval of agenda

John presented the agenda and asked for comments. New item added, 7.1 Advice on EDA Symposium as IC activity. Motion to approve (Oleg); Second (Howard). No objections to unanimous approval, as amended.

# 4. Activity Terminations

# 4.1. IC-11-002 IEEE 802.11 Patent Pool Exploratory Forum

Status Report of Activity indicates purpose of request to terminate. Request is being made by Activity Chair.

Motion to recommend termination (Wael), second (Oleg). No objections to unanimous approval.

### 5. New/Revised ICAIDs

#### 5.1. IC12-006-01 IEEE Actionable Data Book for STEM Education

Tyde Richards presented an overview of the ICAID and responded to questions. Management structure wording was discussed. As a result of the discussion, minor modifications were made to the ICAID. There were questions regarding the Activity developing a prototype or a product implementation. The language was changed to "proof of concept demonstrator".

Motion to recommend approval as modified (Wael), seconded (Yatin). No objections to unanimous approval.

5.2. IC12-007-01 Systems & Components for Energy Routers

Sam presented an overview of the ICAID in lieu of Matt Wilkowski (who was traveling in China). Sam responded to questions from the committee, and a couple of minor changes were made to clarify the wording in the ICAID. Motion to recommend approval as modified (Oleg), seconded (Wael). No objections to unanimous approval.

# 6. Activity Status Reports

Discussion took place as to how often reports should be made. Quarterly may be too frequent. Also, discussion took place on the need/propriety of reports to ICCom when the activity is under another sponsor. There needs to be a balance between ICCom getting the appropriate amount of information and becoming a burden to the activity. No specific action taken on this topic. Jim to use own best judgment about how frequently to request reports from each activity on a case-by-case basis.

# 7. Potential future ICAIDs (under discussion/development)7.1. Advice on EDA Symposium as IC activity

There was a discussion regarding the need for initiating an IC activity, as the symposium moves from its current home to become an IEEE activity. Yatin discussed issues regarding moving the symposium to IEEE Conference Services. A "test run" under the IC program may be a good alternative. More information is needed about Conference Services' rules. Yatin & Jim to look into this, with help from Mary Lynne Nielsen and Moira Patterson.

Three other potential future ICAIDs were also mentioned:

- Electric Vehicle Wireless Power Transfer ICAID imminent.
- DC in the Home ICAID under development by potential leader.
- Stray Voltage Data Repository Initially working together with Smart Energy Data Repository.
